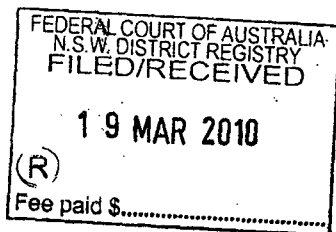

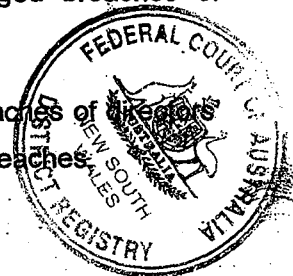
Originating process
(rules 2.2 and 15A.3)

A. DETAILS OF APPLICATION

This application is made under sections 237, 241 and 242 of the Corporations Act.

The Plaintiff, a director of the Company, applies for leave to bring proceedings in the name of the Company:

- (a) against two directors of the Company in respect of alleged breaches of directors' duties; and
- (b) against Metminco Limited, for involvement in the alleged breaches of directors' duties and knowingly receiving property as a result of those breaches.




On the facts stated in the supporting affidavit(s), the Plaintiff claims:

1. An order that the Plaintiff have leave to bring proceedings, substantially in the form of the draft application and statement of claim exhibited to the affidavit of Rodney Thomas Hudspeth sworn 19 March 2010, in the name of Hampton Mining Limited ("Company").
2. In the alternative, an order that the Plaintiff have leave to bring proceedings, in the name of the Company, for preliminary discovery in relation to the claims

identified in the draft application and statement of claim exhibited to the affidavit of Rodney Thomas Hudspeth sworn 19 March 2010.

3. An order that the Company make available to the solicitors engaged by the Plaintiff for the purpose of bringing the proceedings for which leave is granted, all documents in the possession, custody or control of the Company that those solicitors reasonably request in connection with the proceedings for which leave is granted.
4. An order that the costs of the proceedings for which leave is granted be paid from the assets of the Company.
5. An order that the Plaintiff's costs of this application be paid from the assets of the Company on a solicitor/client basis.
6. Such other relief as the Court thinks fit.

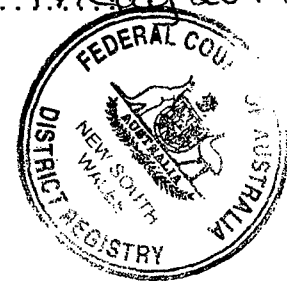

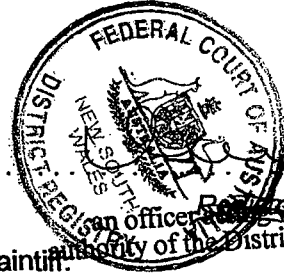
- (a) the application may be heard and final relief given;
